

Scitech Lab – School Holiday Competition

Terms and Conditions

1. Method of Entry

To enter this competition, entrants must purchase at least one (1) ticket for any Scitech Lab school holiday workshop in January 2020. Two (2) winners will be selected at random by a Scitech representative.

2. Duration of the promotion

The competition will be open to Scitech members from 9:00 am Wednesday 1 January 2020 and close 5pm on Thursday 23 January 2020 (AWST).

3. Eligibility

Participants must be Australian residents and be 18 years of age or older to be eligible to win prizes. Participants under 18 years of age must participate with a Parent or Guardian. In the instance that the winner drawn is under the age of 18, the prize will be awarded to the winner's Parent/Guardian.

Entrants must have a valid Scitech membership and a confirmed booking for a Scitech Lab workshop. Each individual workshop ticket sale equates to one competition entry. There is no maximum for the number of entries per person.

Scitech Staff and Volunteers, their immediate families and companies associated with this promotion are ineligible to win prizes.

4. Winner selection

The two (2) winners will be selected at random from the list of valid entries during the promotional period. All winners are at the discretion of Scitech. The prize winners will be drawn and contacted on Friday 14 February 2020.

5. Nature and value of the prizes

The prizes for this competition are two Scitech Discovery Shop vouchers, valued at \$100.00 each. The prize is non-transferable and cannot be exchanged for cash or alternative prizes.

The prize can be claimed in person from the Scitech Discovery Centre at the address listed on the Scitech website (www.scitech.org.au).

6. Method of advising result

The prize winners will be contacted via email, to arrange collection of the prizes.

7. Claiming of prizes

The prize winners will have 14 days from the date of notification to claim their prize. If the

prize remains unclaimed after 14 days, Scitech reserves the right to reassign the prize if appropriate. The first winner has no claim to any prizes should they fail to claim their prize within 14 days of notification.

The prizes will be awarded in person at Scitech, City West. If the winner is unable to attend in person, alternative arrangements will need to be made by the winner, at the cost of the winner.

8. Conditions of entry

The prizes are non-transferable and not exchangeable. Scitech will not be responsible or liable if for any reason beyond their reasonable control any element of any prize is not provided.

Scitech may, subject to government regulations, substitute a different prize of equivalent value in place of any prize referred to in these terms and conditions.
